EXHIBIT RESTRICTIONS | Exhibitors whose focus is TENS Units, LED Skincare (Facial and Body), Cosmetic Products, handheld massagers or any others with aggressive sales tactics are **not allowed under any circumstance**. No exhibitor or part of an exhibit will be admitted to any space until rental of that space has been paid in full. No Exhibitor may dismantle the exhibit until after the closing hour of the show. The exhibitor shall properly staff the exhibit during the show hours. Exhibitors are liable for any damage caused to building walls, floors or columns, or other exhibitors' property. No helium balloons are allowed in the convention center exhibit hall. Any person, firm, or organization not having contracted with KANPNM for the occupancy of space in the exhibit hall will not be permitted to display or demonstrate any products, processes, or services, solicit orders, or distribute advertising materials in any hotel used by KANPNM to house registrants. TERMS AND CONDITIONS

- 1. LOCATION AND DATES:** The 38th Annual Coalition Conference presented by KANPNM will be held April 15-17, 2026, at the Crowne Plaza Louisville Expo Center, 850 Phillips Lane, Louisville KY 40209.
- 2. SPACE CONTRACTS:** Contracts are awarded, and displays are assigned on a first-come, first-served basis with consideration for sponsorship levels. To apply for a display, complete and return the contract with full payment by April 5, 2026. No refunds will be granted for display space or advertising. KANPNM shall have the full right to consider this contract terminated and to retain as liquidated damages all monies paid and to lease that Exhibitor's space to another Exhibitor. KANPNM reserves the right to decline or prohibit any display that, in their judgment, does not fit the character of the conference. This reservation is all-inclusive as to persons, things, printed matter, products, and conduct.
- 3. SPACE ASSIGNMENT:** Exhibitor Spaces will be assigned in the order contracts are received by KANPNM. In all cases, efforts will be made to assign space in compliance with the applicants' choices; however, no guarantee is made by KANPNM that Exhibitors specifications will be met. KANPNM will provide display space to the Exhibitor as indicated on the official floor plan, insofar as possible, but reserves the right to make any changes in the interest of any Exhibitor or KANPNM.
- 4. SUBLETTING SPACE:** No Exhibitor may assign, sublet, or apportion his or her space in whole or part, nor exhibit any products or services other than those manufactured or handled in the normal course of his or her business. All activity must be confined to the limits of the exhibit display area.
- 5. INSTALLATION AND DISMANTLING:** All exhibit installations must be completed between the hours of 4:00 pm and 6:00 pm on Tuesday, April 14, 2026; 8:00-11:00 am Wednesday, April 15, 2026; 8:00-10:30 am Thursday, April 16, 2026, any space not claimed and occupied or for which no special arrangements have been made by aforementioned times may be resold or reassigned by KANPNM without any obligation on the part of KANPNM for any refunds whatsoever. Dismantling of displays must not begin until after the exhibits close at the times listed in the Exhibitor Prospectus. All exhibits must be removed, and the building vacated by 5:00 pm Thursday, April 16, 2026. No installing, dismantling, rearranging, repairing, servicing, removing, or supplementing of exhibits will be permitted during the viewing hours without the permission of KANPNM. Exhibitors are required to participate during all show hours each day as listed in the Exhibitor Prospectus.
- 6. EXHIBITOR'S ADMISSION CREDENTIALS:** Exhibitors must furnish KANPNM with an advance list of their representatives who will be setting up the booth. Representatives must check-in/register upon arrival at the exhibitor registration desk and must always wear company identification badges and KANPNM exhibitor badges (furnished by KANPNM) while in the Center.
- 7. SALE OF MERCHANDISE:** Exhibitors may not sell products on the exhibit floor during regular exhibit hours unless they have prior approval. Exhibitors whose focus is TENS Units, LED Skincare (Facial and Body), Cosmetic Products, handheld massagers and any others with aggressive sales tactics are not allowed under any circumstance. Should an exhibitor representing these categories be found on the exhibit floor, they will be removed from the exhibit floor immediately with no refund of funds paid. The vending Exhibitor will hold KANPNM harmless from every claim of any kind that may arise from the sale of such products, including without limitation, any consumer suit, complaint, or demand; any product liability suit; or any other claim, demand, or suit, whether in a court of law or equity or in an administrative forum. KANPNM reserves the right in their sole discretion, to prohibit or discontinue sales for any reason at any time. Exhibitors are responsible for all permits required by law or local ordinance. If an exhibitor engages in on-location transactions, the exhibitor will be responsible for complying with all federal, state, and local laws that may pertain to such sales. Each exhibitor is responsible for making this contact.
- 8. NOISE, SOUND, AND COMBUSTIBLES:** Use of the display area shall not interfere with other exhibitors. Musical instruments, radios, sound-motion picture equipment, record players, noise-creating devices, or amplifying systems shall be operated only at a level that will not interfere with other Exhibitors or add unduly to general acoustical inconvenience, and their operation must conform to KANPNM requirements. Flammable fluids, substances or material, the use of which is in violation of city, county, or state laws or regulations, may not be used in any booth.
- 9. COPYRIGHT POLICY:** The Copyright Laws require the payment of a user fee before any performance of copyrighted work (such as music or literature). Exhibitors are responsible for procuring permission to use any

copyrighted work that is performed, broadcasted, displayed, or used in KANPNM publications, which is supplied to KANPNM by the Exhibitor. Each Exhibitor assumes full liability for any infringement of the Copyright Act committed by or on behalf of such Exhibitor and agrees to hold KANPNM and their employees and agents harmless and to assume all costs and damages for any direct or indirect liability KANPNM may incur by such infringement. For any infringement committed, each Exhibitor agrees to assume the duty to defend, including paying for all costs associated with the infringement defense, giving KANPNM right to control litigation and choice of counsel.

10. NON-LIABILITY: It is expressly understood and agreed by each contracting Exhibitor and his or her guests that neither KANPNM, nor its employees, nor its contractors shall be liable for loss or damage to the goods or properties of Exhibitors. All property of the Exhibitor is understood to remain under his or her custody and control in transit to, within, or in transit from the confines of the Exhibit Hall, subject to the rules and regulations of this conference. By signing the contract, Exhibitor releases and agrees to indemnify KANPNM, its managers, officers, members, sponsors, employees, and agents, and indemnify and save them harmless from any suit or claim for property damage or personal injury (including punitive damages) by whosoever sustained, including Exhibitor and its employees, servants, independent contractors, and agents of every kind or employees on or about the Exhibitor's space or arising out of Exhibitor's participation in the exhibition, excluding such damage or injury resulting in any part from the negligence of one or more of the aforementioned indemnities. The performance of this contract by either party is excused if made impossible or illegal by acts of God, war, government regulation, disaster, civil disorder, curtailment of transportation facilities, power outage, or other emergency over which any party has no control. This agreement may be terminated for one or more of such reasons by written notice from one party to the other, but upon termination for any such reason, Exhibitor is not entitled to a refund or reimbursement. The Exhibitor does not have the right to request a refund because the facility fails to provide any service (e.g., electricity goes out and attendees cannot see exhibit). Failure by the Exhibitor to comply with these rules and regulations as agreed by the parties or the breach of any representation, warranty, or guarantee by the Exhibitor shall render the Exhibitor liable for direct and consequential damages, expenses, allocations of overhead, etc., including but not limited to, reasonable attorney's fees. This agreement represents the complete understanding of the parties and may be amended, modified, or otherwise altered only pursuant to the mutual written agreement of the parties.

11. GENERAL: KANPNM reserves the right to make such additional conditions, rules, and regulations as KANPNM deems necessary to enhance the success of the Coalition Conference. Failure of KANPNM to declare any violation of these rules immediately upon occurrence thereof, or delay in taking any action in connection therewith, shall not waive such violation. KANPNM shall have the right to declare any violation at any time and take such action as might be lawful or authorized hereunder, either in law or in equity. The receipt of any rent or payment by KANPNM, with or without knowledge of any breach or violation by KANPNM of any conditions, terms, or covenant, hereunder shall not be determined or considered as a waiver of any provision hereunder.

12. KANPAM NAME AND LOGO: Exhibitors must have approval from the Kentucky Association of Nurse Practitioners/Nurse-Midwives (KANPNM) to use the official KANPNM logo, KANPNM Coalition Conference logo and/or organization name: Kentucky Association of Nurse Practitioners/Nurse-Midwives (KANPNM).

13. EXHIBITORS SHALL BE FULLY RESPONSIBLE to pay for all damages to property owned by the Crowne Plaza Louisville Expo Center, Louisville KY, its owners, or managers which result from any act or omission of Exhibitor. Exhibitor agrees to defend, indemnify, and hold harmless, Kentucky Association of Nurse Practitioners/Nurse-Midwives (KANPNM) and Expo Center, its owners, managers, officers, or directors, agents, employees, subsidiaries, and affiliates, from any damages or charges resulting from Exhibitor's use of the property.
